Authorization is hereby granted for movement on MnDOT Permit #4I84396 subject to compliance with the Minnesota Traffic Regulation Act. Under the terms, conditions, and restrictions listed on the current MnDOT General Provisions and as follows:

The above self propelled vehicle may not be used to tow trailers or semi-trailers under the condition of this permit.

MAXIMUM AXLE WIDTH IS 0'0" Max GVW: 80,000

Maximum Overall Length: **110'0"** Width: **16'0"** Height: **15'0"**

Dimensions: Front/rear overhang may not exceed 30 Feet total and side overhang left may not exceed right

Movement is not authorized when weather or road conditions are hazardous. Rear visibility required. At night required signs must be lighted or reflective and visible from at least 500 feet. Load and vehicle unit(s) must be outlined every 20 feet in lights.

*Limits for Oversize/Overweight (OSOW) Annual Permit Attachment

This permit does not increase your gross vehicle weight registration. Contact the Driver and Vehicle Services Prorate Office at 651-205-4141 or DVS.prorate@state.mn.us (Z06)

Loads exceeding 11'0" wide. or 14'6 high. or loads that are overweight require a MnDOT system ROUTE PRE-APPROVAL, which must be made available to law enforcement or MnDOT official upon request. Check www.511mn.org before moving as road and travel conditions and/or closures can occur unexpectedly prior moving.

MnDOT strongly encourages using the Oversize/Overweight permit routing system to verify routings for all permit dimensions and/or weights.

Special Travel Restrictions - unless otherwise noted differently on the MnDOT Route Approval

ESCORT REQUIREMENTS

*When exceeding 14'6 wide, lead and rear certified escort required on two-lane non-divided roadways. Rear certified escort required on divided roadways.

*Certified Lead Peace Officer escort required anytime a load and/or vehicle encroaches over the centerline on two-lane non-divided roadway.

*Constant radio communication required between all escorts and permitted truck.

*MnDOT reserves the right to require additional escorts.

TRAVEL RESTRICTIONS

*For Travel Hours- see permit attachment Minnesota General Provisions

*No move if wind gusts prevent vehicle(s) from staying within its travel lane

*Flag (lights at night) widest point(s) of load, when exceeding 9'0" wide

*Flag (lights at night) at end of overhang, when any combination exceeds 75'0" long, or single vehicle exceeds 40'0" long

*Flag (lights at night) every 20 feet along load/trailer combination when exceeding 75'0" long

*OVERSIZE LOAD sign with flashing amber lights required front and rear when exceeding 12'6" wide and/or exceeding 95'0" long. Signs must be reflective or lighted at night. (Z08)

Routes other than MN, US or interstate may require local permits.

This permit does not supercede any road or bridge load posting.

In accepting this permit, the permittee agrees that all information shown is correct and accepts all responsibility for any damage caused by the movement for any reasons.
